How many houses belonging to Housing New Zealand have been demolished due to fire damage over the past five years?

How many Housing New Zealand houses have been demolished or deemed unliveable due to fire damage over the past five years?

Please include the cost that this resulted in for Housing New Zealand.

Please include the location (region, town or city) of each dwelling demolished after fire damage.

You clarified that your request related to only those properties that were demolished as a result of fire damage. I have included the information requested in the attached appendices. Due to the way Housing New Zealand records this information, please note that:

- the number of properties demolished includes those with a NET Book Value above \$10,000, and does not include partial demolitions (such as a garage)
- the costs include both partial and full demolitions.

Housing New Zealand takes the health and safety of our tenants very seriously. We will provide support to any tenants whose home has been affected by fire damage, including paying for motel accommodation until they can be re-housed.

It is our policy to have fitted, working photo-electric smoke alarms in all bedrooms, hallways, and living areas, and these are checked twice yearly. Housing New Zealand also provides fire safety information to our tenants on our website and through our tenant newsletters.
