On 27 January 2019, you requested the following information under the Official Information Act (the Act):

How much of the "Community Group Housing Market Rent Top-Up" appropriation in the Estimate 2019/20 has been committed, and to what Community Housing Providers?

The 2019/20 appropriation for the Community Group Housing Market Rent Top Up is \$13.891 million.

These funds have been applied to the rent for 1425 properties tenanted by 221 different community groups throughout New Zealand.

I am withholding the names of 61 of these organisations which provide services to vulnerable people, who could be in danger if their location was to become public. The release of these names could make their location discoverable. This information is being withheld under Section 9(c) of the Act, to avoid prejudice to measures protecting the health or safety of members of the public.

The names of the other 160 community groups are included in the attached list.
