Thank you for your request under the Official Information Act 1982 (the Act) to Kāinga Ora – Homes and Communities, dated 17 May 2023, for the following information:

"I am doing a University assignment at Victoria University that looks at planning and creating a timeline for a hypothetical residential development. I have studied your Arlington Street development before and would be a similar match to my brief. I ask if I am able to have access to any planning, project timeline, Gantt charts, project phases / tasks etc if I'm allowed to have access?"
