Thank you for your official information request, which was transferred to Kāinga Ora – Homes and Communities on 30 October 2020 asking:

- How many State houses existed in Glen Innes before the redevelopments occurred? (I am
  coming across the number as 60% of the residential houses were classified as state housing but i
  dont not have any credible information.
- How many state houses were handed over to TRC in 2016?

With regard to how many state houses existed in Glen Innes before the redevelopments occurred, I am unable to provide you with this information as Kāinga Ora records housing data by Territorial Local Authority and not by suburb. Within Auckland, reporting areas are further refined by Community Boards. I am therefore declining this aspect of your request under section 18(g) of the Official Information Act 1982 (OIA) as the information is not held.

However, Kāinga Ora publishes quarterly reporting on it housing stock and the information that we hold, most closely related to your requested area of Glenn Innes, is the Maungakiekie-Tamaki Community Board. In March 2016 the property count for Maungakiekie-Tamaki was 4864. By June 2016 that figure was reported to be 2168. I also note that on the Tamaki Regeneration 2017 Briefing to Incoming Ministers published on the Tamaki Regeneration website advises in its overview that 'Tāmaki is located approximately 12 kilometres southeast of Auckland's central business district ... with approximately 2,800 of the 5,000 existing homes in the area being social houses.'
