Thank you for your email of 8 September 2020 in which you make the following requests:

Can I please request the number of housing developments, and the number of total dwellings that have been built since January 2018 in the following Auckland suburbs: Mt Wellington, Onehunga (and Oranga/Te Papapa), Ellerslie, One Tree Hill, Royal Oak, Penrose. These suburbs are within the Maungakiekie general electorate.

Can I also please request the number of housing developments, and the number of total dwellings, that are currently planned to be started and/or completed between September 2020 and December 2023.

With regards to the first part of your first request, since January 2018 Kāinga Ora has had 91 unique development projects and these provide a total count of 933 dwellings.

Kāinga Ora – Homes and Communities does not report the number of state houses by electorate. See the Kāinga Ora website for the number of managed properties by Territorial Local Authority at https://kaingaora.govt.nz/publications/housing-statistics/. This information is published quarterly.

In response to the second part of your request from September 2020 to December 2023 the number of housing developments currently planned to be started or under construction is 81 and the number of total dwellings that are currently planned to be started and/or completed is 945.

The number of housing developments in the pipeline undergoing feasibility is 36 and the number of the total dwellings within these developments is 727. These numbers are subject to change.
