Thank you for your email of 05 August 2021 requesting information relating to Universal Design under the Official Information Act 1982 (the Act). I have addressed each of your questions in turn below.

### Figures for Kāinga Ora's housing stock, broken down by housing style.

### How many Kāinga Ora homes currently meet Universal Design standards?

Kāinga Ora has not historically tracked the number of our houses that meet universal design standards; however, this is now being tracked as of 1 July 2021 in line with our accessibility policy and will be available in future reporting periods.

As this information does not exist I am refusing this part of your request under section 18(e) of the Act.

## How many Kāinga Ora homes have been built for public housing tenants since January 2020, and of these, how many were built to Universal Design standards?

Between 01 January 2020 and 31 July 2021 Kāinga Ora has built 2,494 properties for state housing purposes. This includes new builds and redevelopments.

As per our response to the previous question, we have not historically tracked this information, however it is being tracked as of 1 July 2021; I am therefore refusing this part of your request under section 18(e) of the Act.

## All correspondence, including reports and briefings regarding the benchmark reporting around the 15 per cent target for Universal Design from January 2020 to date.

All correspondence on Kāinga Ora's benchmark reporting cannot be made available without substantial collation and research. I am therefore refusing this part of your request under section 18(f) of the Act.
