Thank you for your request of 1 September 2025 to Kāinga Ora – Homes and Communities, for the following information under the Official Information Act 1982 (the Act):

*“Please may you kindly provide us with the Building Consents report again as follows:
Building Consents ISSUED. Period: 1 June 2025 to 30 August 2025. Area: Kainga Ora all projects, NZ Wide.”*

Kāinga Ora owns and manages around 78,000 public and supported homes. The Kāinga Ora Address Release Policy states that address information is to be treated as part of our customers' personal information and can only be released when we have a lawful basis to do so, and once we have confirmed for ourselves that the lawful basis exists, including to the specific situation or request. Accordingly street numbers are withheld under section 9(2)(a) of the Act to protect the privacy of tenants.

Please note consents issued by Kāinga Ora that fall outside Consentium's scope such as those involving unmitigated natural hazards assessed by the relevant Territorial Local Authority (TLA) are not included. In those cases, building consent applications have been lodged directly with the appropriate regional TLA.
