



2. Updates for Hon Chris Bishop, Minister of Housing





Finesse Residential Voluntary Administration

- Kāinga Ora is currently in an unconditional Development Agreement with Finesse Residential. Finesse has agreed to purchase 167 single home lots within the Te Kauwhata (Lakeside north of the Waikato region) Kāinga Ora development.
- The lots are planned to be used for a mixture of market and affordable homes, consisting
 of three and four-bedroom properties.
- As of 29 July 2024, Finesse Residential has been placed into voluntary administration. A
 receiver has been appointed.
- To date, Finesse has completed 33 of the total 167 lots, with nine lots currently under construction.
- Kāinga Ora is currently working to establish its exposure and rights under the Development Agreement, but initial indications suggest that the value is low.

High Court decision regarding Osterley Place, Manukau

- On 9 December 2022, Auckland International Airport Limited (Airport) lodged judicial review proceedings against a decision made by Auckland Council to grant resource consents for a Kāinga Ora mixed-use development at 9 Osterley Way, Manukau.
- The site in question falls within the Metropolitan Centre Zone and is subject to the Moderate Aircraft Noise Area (MANA) contour within the Auckland Unitary Plan.
- The Airport sought a reversal of the decision to grant the consent, and for it to be given standing as an affected party in relation to consideration for any future residential applications relating to the site.
- The grounds for the review related to the potential for future residents of the development (and any residential developments within the Airport's noise contours) to complain about aircraft noise in such a way that might lead regulators to place restrictions on the Airport's future operations. If argued successfully, the decision could have wide-ranging ramifications for future urban development in Manukau and beyond.
- There are no allegations Kāinga Ora has acted unlawfully in any way.
- The judgment, delivered on 26 July 2024, is that the Auckland Council erred in law. The
 Notification Decision and the Consent Decision are unlawful and are set aside. The
 matter is remitted to the Council to consider afresh and in accordance with law. The
 matter should be reconsidered by planning officers not involved with the previous
 decisions.

Kāinga Ora Organisation Optimisation Change Process – Te Kurutao team

- Kāinga Ora continue to work through our consultation and change processes as we seek to ensure our organisation is appropriately sized to meet its obligations now and in the future.
- You were informed earlier this week that Te Kurutao Group Māori has been affected by the change driver, budget appropriated funding. This reduction in funding means that Te Kurutao is working through resetting and restructuring processes to align expenditure and activity with the reduced funding.
- While there will be ongoing requirements for the work that Te Kurutao Group Māori delivers and supports, Kāinga Ora is no longer funded for the current number of team members in Te Kurutao Group Māori, resulting in a need to reduce the number of employees.
- A draft proposal for consultation with affected people in Te Kurutao Group Māori sets out how we propose to match our size to our new level of funding, while continuing to deliver and support the work that we anticipate will continue to be required of the Group.
- This draft consultation proposal has been prepared in keeping with the understanding that
 Te Kurutao Group Māori provide te ao māori perspectives in the planning and delivery of
 homes, urban development, and infrastructure projects, and as a result, supports better
 decision-making and outcomes for all groups.
- Furthermore, the operating principles of Kāinga Ora include that it partners with Māori to support them to meet their housing aspirations, and Te Kurutao Group Māori is integral to this principle being met.

Kāinga Ora Organisation Optimisation Change Process - National Engagement and Partnerships team

- The National Engagement and Partnerships (NEP) team is a centre of expertise, providing strategic guidance, frameworks and support on engagement, community development, partnerships and place-making for the organisation.
- A change proposal was started on 31 July 2024 to resize and realign the team to improve
 the efficiency of how they operate and deliver services. It is proposed that NEP be
 disestablished and that its key functions and activities are delivered through other parts of
 the organization.
- Of the existing 23 FTEs in scope of the change, 12 roles would be disestablished, 11 roles would be retained with minimal changes (8 within NEP, 3 outside of NEP), and 7 new roles would be created. There would be a proposed net reduction of 5 FTEs.

3. Updates for Hon Tama Potaka, Associate Minister of Housing

Enhanced sign-up process fast tracks families from emergency and transitional housing

- Nine families, all who have had extended stays in emergency and transitional housing, have moved into stage one of a larger housing development in Gisborne.
- The homes are across the road from a school and are being tenanted by families with children. In total, 35 children are moving from emergency and transitional housing into stage one of this development, including three families with six children each.
- The new homes were blessed last week (23 July 2024) and immediately after all nine families started moving in.
- To ensure there was no delay between the homes being completed and the families taking up residence, Kāinga Ora teams worked closely with MSD to identify and prematch applicants during the construction period. Additionally, a new approach to completing the tenancy agreement sign-up process was used.
- On the day before the new homes were blessed, the nine families came together to meet their housing support manager and go through the tenancy agreement. The families will be living relatively close together and it was a chance for them to meet each other and hear the same korero about their rights and obligations. The agreements were signed and any issues that could delay an immediate move from emergency housing worked through.
- Gisborne is a priority location in the Ministry of Housing and Urban Development's Public Housing Plan.

Kāinga Ora and Ngāti Maniapoto Relationship Agreement

- On 24 July 2024, Kāinga Ora and Ngāti Maniapoto (through Te Nehenehenui Trust, their Post Settlement Governance Entity) signed a Relationship Agreement. At the same event Te Nehenehenui also signed relationship agreements with the Ministry of Health; Te Whatu Ora; Ministry of Housing and Urban Development and Accident Compensation Corporation.
- The Agreement sets out the relationship principles Te Nehenehenui Trust and Kāinga
 Ora, as well as a commitment to working together to progress shared interests and
 outcomes that contribute to Te Kawau Rukuroa Te Nehenehenui 2050 Strategy. This
 Strategy has aspirations for Ngāti Maniapoto to live on their whenua within the
 Maniapoto Rohe, providing access to affordable quality housing within Kainga Ora's
 mandated settings.
- Kāinga Ora is involved in the development of Waipa, Waitomo and Otorohanga housing strategies, which provide an opportunity for a collective contribution to the housing outcomes in the Ngāti Maniapoto rohe.
- Furthermore, Kāinga Ora have started a new housing development in Te Kuiti. This development will deliver 11 new whare (the first to be delivered within Te Kuiti since the 1980s). These are due to be delivered May 2025.
- Te Nehenehenui have been engaged in this development, they led the karakia we had onsite before ground works began and are gifting us with names for the development and the new street in the development.
