Northland Pet Desexing Campaign

Kāinga Ora in partnership with the SPCA and a number of Northland vet clinics have a desexing campaign underway which will run until 30 June 2025. The SPCA will cover the cost of desexing and microchipping 400 cats and 400 dogs belonging to Kāinga Ora customers in Whangārei and Kaitaia.

Pets can be great companions and support people's wellbeing. However, cost can be a barrier to our customers doing the right thing and getting their pets desexed.

Our tenancy team are promoting this opportunity when visiting customers in their home or calling if they know the customer has a pet and connecting them with the vet clinic.

Westpac Meeting Update
Westpac held an affordable and social housing roundtable this week. Attendees included Kainga Ora, Housing Foundation NZ, Community Housing Association, Ngāti Tamaoho Settlement Trust, TW Group, Modus Group, Wellington Company, and Queenstown Lakes Community Housing Trust.
The key theme was how can the community and finance sectors work together to help with additional housing supply. Discussion was had on the need for the Reserve Bank to recognise the value of the Government cashflow stream by carving out an Australian and New Zealand Standard Industrial

Classification (ANZSIC) specific for social housing.



The need for longer term certainty beyond the election cycle (a more bipartisan approach). The need to strengthen the contracts with CHPs to remove the termination for convenience clause to enable more scaled interest in the sector. Of interest was Westpac's ability to do longer term swaps (circa 20 years) to help mitigate interest rate volatility risk for the CHP sector. This was the start of more korero in this space.
