2. Updates for Hon Chris Bishop, Minister of Housing

3. Updates for Hon Tama Potaka, Associate Minister of Housing

Tenancy placements at Te Ō complex

Kāinga Ora is working closely with Wellington City Mission to gradually place people into the homes at Te Ō. A considered approach is being taken to tenant the homes in line with international best practice, which ensures we have the right mix of people with low, medium, and high support needs living there. This process was expected to take some time and it is important to community wellbeing that we get this balance right. Currently 38 of the 80 homes at Te Ō are occupied.

Assessments and placement decisions are being considered by Kāinga Ora and Wellington City Mission on an ongoing basis. We have a placement plan in place for Te Ō which will result in the complex being fully occupied by 13 December 2024. This plan allows for six customers to move into Te Ō staggered throughout each week between now and 13 December 2024. This is the agreed maximum rate that enables the development of the community and maintains community cohesion. 22 individuals have been assessed and will be occupying their unit in the coming weeks in line with our staggered placement plan. 20 units are in the process of being allocated to suitable individuals subject to assessments of their suitability for Te Ō.

Fire at Te Mātāwai

Te Mātāwai is Kāinga Ora's largest single-site supported housing development located on Greys Ave in the Auckland CBD. A fire started in one of the apartments in Te Mātāwai around midnight on Wednesday 23rd October 2024.

Staff were alerted by the fire alarm inside the apartment. Emergency services were called and were able to rescue the tenant who was taken to hospital where they remain. Immediately affected tenants were evacuated, but no other tenants or staff were harmed. At around 3am tenants were given the all clear to return to their apartments.

New Zealand Police and Fire and Emergency New Zealand are investigating this incident. Kāinga Ora staff will be providing CCTV footage and statements to support the investigation.
