2. Updates for Hon Chris Bishop, Minister of Housing

Social Services and Community Committee Hearings

On 18 September the Social Services and Community Committee considered the petition of Joseph Griffen seeking work to stop on a development to build 20 homes at 134 Port Street East in Feilding. Daniel Soughtton, DCE Central and local regional director Graeme Broderick appeared for Kāinga Ora. The petitioner has concerns about the impact of the development on nearby property values and the development not being notified by the local authority. Members asked a range of questions including the level of community consultation. Kāinga Ora have an agreement with GL Corporation Limited that confirms our intention to purchase 20 homes for social housing once completed. Once the contractual conditions were met Kāinga Ora engaged with the community and addressed the concerns and questions raised.

On 25 September the Committee heard from petitioner Veronica Turketo, and Marie Olsen, Whangārei District Councillor, seeking to stop the social housing development in the Kensington area of Whangarei. Caroline Butterworth, DCE Northland/Auckland and local regional director Jeff Murray represented Kāinga Ora. Questions from members centred on the accessibility of the homes being delivered and intensification. Originally seven redevelopment projects were proposed. Four have since been built, one is underway, two projects, which were of the greatest concern to the community are not proceeding, and one is under assessment. Feedback about the design and quality of the completed homes is positive.
