1. Updates

New homes for Feilding

Kāinga Ora is looking to deliver 20 new homes in Feilding, through an intent to purchase agreement with private developer, GL Corporation Limited. Once completed, the new homes at 134 Port Street East, Feilding, will be used for social housing. A resource consent application has been issued and the homes are expected to be ready for local people and families to move into by mid-2026.

The development is in the early stages, and we are working collaboratively with the developer to ensure the homes will best meet the needs of the people and families who will live there, as well as the community.

Kāinga Ora has engaged with the local community about our intentions for this site and we will continue to keep them updated.

We will take over ownership of the development once the homes are finished, and we will keep you updated on the progress.

IAF funding to enable 200 dwellings in Motueka

The Infrastructure Acceleration Fund (IAF) is a \$1 billion fund to support councils to build new or upgraded bulk infrastructure - such as roading, waters and flood management – to enable new homes to be built by developers in areas of high housing need. Councils are recipients of IAF funding and payments are made to councils as the infrastructure projects reach key milestones.

This item provides you with an understanding of issues raised by the Mayor of Tasman District Council with the Minister of Transport, should the Minister seek to discuss them with you.

Tasman District Council is the recipient of \$1.2 million of IAF funding to enable the building of the road that will enable 200 dwellings to be built (including 50 social, 30 papakāinga, 70 lower-cost and 50 market dwellings). The developer is Wakatū Inc, who are developing land recently returned to local iwi via a Treaty Settlement, upon which the road will be constructed. This land is vested to Wakatū Inc.

At the meeting with the Minister of Transport on 31 January 2024, the Mayor sought to discuss maintenance funding for the road.

Wakatū Inc wish to retain all of the land in their ownership in perpetuity, including the land where the public road will be constructed. This is a principled stand based on a desire of Wakatū owners to retain all remaining original landholdings and not sell or vest. In their view, they have lost too much already under duress and/or treaty breaches.

However, under these circumstances, the land would be considered a 'private' road under the current Government Policy Statement on Land Transport (GPS).

New Zealand Transport Agency Waka Kotahi have advised that under the current GPS, they cannot provide standard roading maintenance subsidy for a road built on privately owned land.

Council and Wakatū have made submissions on the draft GPS for 2024-2027 seeking a change to the current situation to allow the maintenance of this public access/roading network (on privately owned land) to be funded by New Zealand Transport Agency Waka Kotahi.

This issue is not a matter for the IAF to resolve or get involved in, as we remain focused on funding infrastructure construction to enable the dwellings. This is a matter that New Zealand Transport Agency Waka Kotahi must resolve with council and Wakatu Inc.

If funding settings remain unchanged, it is likely Wakatū and Council will be at an impasse and the development may not proceed, at least in the timeframe contemplated by Council and Kāinga Ora.


